 - c) Any supporting documents and testimonials;
 - d) Letter of appointment to the current substantive post; and
 - e) Letter of appointment to the previous post.

The successful candidate will be required to satisfy the requirements of Chapter Six of the Constitution of Kenya 2010 and should submit among other documents;

- (i) Certificate of Good Conduct from the Directorate of Criminal Investigations;
- (ii) Clearance Certificate from the Higher Education Loans Board;
- (iii) Tax Compliance Certificate from the Kenya Revenue Authority;
- (iv) Clearance from the Ethics and Anti-Corruption Commission and
- (v) Credit Clearance Certificate from Credit Clearance Bureau approved by the Central Bank of Kenya.
